You visited Basra last week. [REDACT] will be sending more detail on the trade elements of the visit separately.

Broadly on the **oil and gas companies** we visited it was impressive hearing about their social outreach and the work they are doing to employ and professionalise local Iraqis – including a focus on those who lived in close proximity to the oil fields. [REDACT] The work of British companies was clearly having an impact on Basrawis, particularly the gas capturing which was improving the air pollution and increasing electricity coverage. [REDACT]

Subject: Meeting with BP in Baghdad - 21.05.2018

Ambassador,

[REDACT], and I met with [REDACT] at his Baghdad office on Monday 21/05/2018.

Here are the key points of the meeting:

- We asked for his views on the reestablishment of **Iraqi National Oil Company (INOC)** which was set up in 1966 but it was merged with the Ministry of Oil (MoO) during Saddam's regime in 1987. [REDACT]

- **Kirkuk** – [REDACT]

Technically the Kirkuk Oil field (which was discovered in 1927) consists of six fields, five of them are under the control of MoO/Iraqi Federal Government (GOI). One field, the Khurmala oil field, was under the control of GOI until 2008 when the KRG forces took control of it. [REDACT]

- **Exporting oil from Kirkuk.** Recently the MoO tendered a project for the building of a new pipeline to Turkey as an alternative to the Kirkuk-Ceyhan pipeline. [REDACT]
